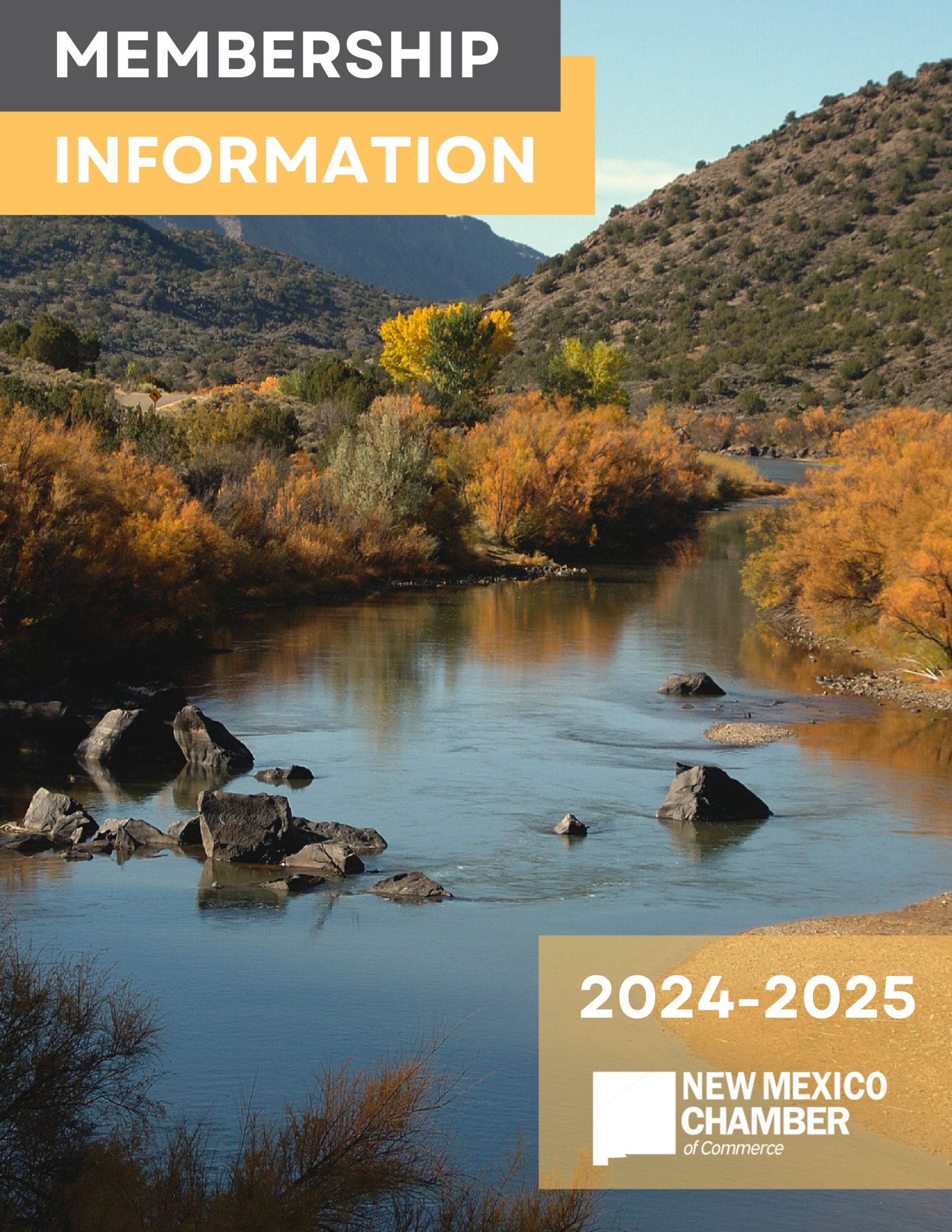

The New Mexico Chamber of Commerce (NMCC) is dedicated to ensuring the voice of New Mexico business is heard year-round, whether at interim committees, during the legislative session or in Washington, DC. And while we pride ourselves on being the “Voice of New Mexico Business” today, we are also working to build our state’s economic prosperity for future generations, creating a business leadership organization that will help transform our state.

NMCC continues the work of making our employees, customers and communities safer by passing key legislation like SB 271, Repeat Felony Offender No Bond Hold and last year’s HB 234 Organize Retail Crime law. The New Mexico Organized Retail Crime Association (NMORCA), a key initiative of the Chamber continues to bring law enforcement, retailers and local chambers of commerce together every month to help arrest and prosecute shoplifters and fencing operations in our communities.

NMCC, through our charitable foundation, the New Mexico Center for Economic Opportunity (NMCEO), successfully launched Be Pro Be Proud, a statewide workforce development initiative to help introduce high school students and young adults to in-demand, high-wage technical career opportunities in New Mexico. In just a few short months, over 5,000 high school students, in over 57 New Mexico communities around the state have participated in the program.

In January, NMCC conducted our annual Voter Pulse Survey, identifying key issues for New Mexico’s voters. Survey respondents listed reducing crime, improving public schools, expanding housing affordability and availability, and growing the economy as their top priorities. These initiatives match our own, and we made strides during this past legislative session toward improving these areas for all New Mexicans.

The New Mexico Chamber of Commerce is committed to building an economy that allows the next generation of New Mexicans to have access to a quality education and the opportunity for a fulfilling and challenging career in our amazing state. We believe that the work of the Chamber and NMCEO is building a better business climate for our state and enhancing prosperity for all New Mexicans.

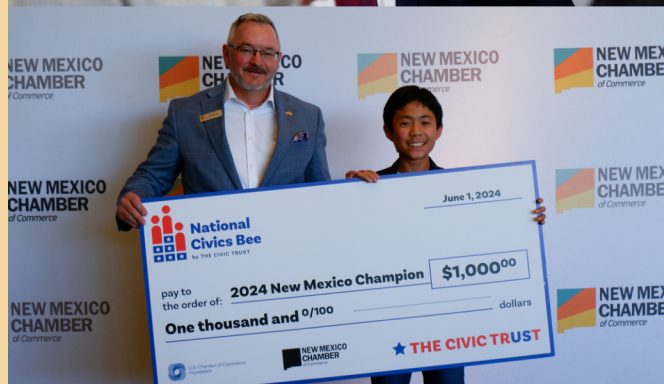

How much time does it take to be a member of NMCC?



POLICY AGENDA DEVELOPMENT

NMCC represents every industry and region in the state. Our membership-driven grassroots policy process incorporates eight different policy committees. Each policy committee meets in the spring and again in the fall to review and update NMCC's policy priorities.



POLICY COMMITTEES

Twice a year, NMCC's policy committees convene through a series of meetings to review NMCC's policy priorities and recommend changes.

GOVERNMENT AFFAIRS COMMITTEE



The Government Affairs Committee reviews and synthesizes all policy committee recommendations into a final report for the membership.



FULL MEMBERSHIP

After the Government Affairs Committee reviews the Policy Agenda, it goes to NMCC's full membership for discussion and approval.

POLICY AGENDA



Once approved by the full membership, NMCC staff and leadership use the Policy Agenda to craft and support and/or oppose specific measures and bills.
